**An Ordinance concerning**

**Town Charges and Fees**

**FOR the purpose of establishing charges and fees imposed and collected by the Town of Riverdale Park that have not previously been established by ordinance; ratifying, confirming and validating the collection of charges and fees imposed by the Town of Riverdale Park prior to the effective date of this Ordinance; providing that the provisions of this Ordinance are severable; and matters generally related to charges and fees imposed and collected by the Town of Riverdale Park.**

**BY adding  
Chapter 23 – CHARGES AND FEES  
Section 23-1  
Code of the Town of Riverdale Park  
(January 2008 Revision)**

**SECTION 1: BE IT ENACTED BY THE COUNCIL OF THE TOWN OF RIVERDALE PARK, That new Section 23-1 be and it hereby is added to the Code of the Town of Riverdale Park (January 2008 Revision), to be under new Article 23 – CHARGES AND FEES, to follow immediately after Section 19-3 of Chapter 19, CARNIVALS AND SHOWS, ETC., and to read as follows:**

**Chapter 23 – CHARGES AND FEES**

**§23-1. IMPOSITION OF CHARGES AND FEE.**

(A) THE TOWN MAY IMPOSE AND COLLECT THE CHARGES AND FEES SET FORTH IN THIS SECTION. THE CHARGES AND FEES SET FORTH IN THIS SECTION ARE IN ADDITION TO THOSE CHARGES AND FEES THAT THE TOWN MAY IMPOSE AND COLLECT PURSUANT TO OTHER PROVISIONS OF THIS CODE.

(B) THE TOWN MAY COLLECT THE FOLLOWING FEES AND CHARGES IN THE AMOUNTS SPECIFIED:

(1) POLICE DEPARTMENT COLLECTION LETTER RELEASES  
- \$25.

(2) POLICE DEPARTMENT FINGERPRINTING - \$40.

(3) POLICE DEPARTMENT FLAGGING RECEIPT - \$25.

(4) POLICE DEPARTMENT VEHICLE IMPOUND RELEASE -  
\$50.

(5) POLICE DEPARTMENT ACCIDENT/INCIDENT REPORTS -  
\$25.

(6) PUBLIC WORKS COSTS FOR ABATING CODE VIOLATIONS WHERE ABATEMENT BY THE TOWN IS AUTHORIZED:

(A) LABOR - \$200 PER HOUR.

(B) EQUIPMENT RENTAL – ACTUAL COST.

(C) DUMPING FEE – ACTUAL COST.

(D) ADMINISTRATIVE COST - 15% OF TOTAL OF LABOR, EQUIPMENT RENTAL AND DUMPING FEE COSTS.

(7) PUBLIC WORKS MATERIAL SALES:

(A) TRASH BAGS - \$9.00 PER ROLL.

(8) PUBLIC WORKS UTILITY PERMIT REVIEWS - \$75 PER PERMIT.

(9) ANNUAL ALARM REGISTRATION FEE - \$40.

(10) PHOTOCOPIES - \$.25 PER PAGE.

SECTION 2: AND BE IT FURTHER ENACTED that the Town Council hereby ratifies, confirms and validates the Town's imposition and collection, prior to the effective date of this Ordinance, of the charges and fees set forth in Section 23-1 of the Code of the Town of Riverdale Park as enacted by Section 1 of this Ordinance as fully as if such charges and fees had been established by ordinance at or before the time of their imposition and collection.

SECTION 3: AND BE IT FURTHER ENACTED that if any provision of this Emergency Ordinance, or the application thereof to any person or circumstance, is held invalid for any reason, such invalidity shall not affect the other provisions or any other application of this Ordinance which can be given effect without the invalid provisions or application, and to this end, all the provisions of this Ordinance are hereby declared to be severable.

SECTION 4: AND BE IT FURTHER ENACTED that this Ordinance shall become effective twenty (20) days after its passage by the Council.
