15 **RATIFICATION OF TOWN EMPLOYEE DEFINED BENEFIT PLAN AMENDMENTS**

17 **FOR** the purpose of ratifying, confirming and validating, retroactively to certain dates, the
18 adoption and execution of Amendments Nos. 1-9 to the Town of Riverdale Park Defined Benefit
19 Plan, Effective April 17, 2000; and matters generally related thereto.

20
21 **EXPLANATORY STATEMENT:** The Town Council adopted a Defined Benefit Plan for its
22 employees, effective April 17, 2000 ("the Plan"). The Town has executed nine amendments
23 (collectively "the Amendments") to the Plan as follows:

25 1. First Amendment executed April 13, 2000, effective April 17, 2000.
26 2. Second Amendment executed June 8, 2000, effective April 17, 2000.
27 3. Third Amendment executed June 17, 2002, effective in parts for Plan Years beginning
28 after December 31, 2000, and distributions after December 31, 1999.
29 4. Fourth Amendment executed June 30, 2003, effective in parts as of July 1, 2002, and July
30 1, 2003.
31 5. Fifth Amendment executed June, 2005, effective as of January 1, 2005.
32 6. Sixth Amendment executed June, 2005, effective as of July 1, 2005.
33 7. Seventh Amendment executed June 30, 2006, effective as of July 1, 2005.
34 8. Eighth Amendment executed June 30, 2006, effective as of January 1, 2006.
35 9. Ninth Amendment executed June 30, 2009, effective as of January 1, 2007.

37 It is not clear which, if any, of the Amendments were adopted by the Town Council. To avoid
38 any question regarding the due adoption of any one or more of the Amendments, the purpose of
39 this Resolution is to ratify, validate and confirm the Amendments and the execution of the
40 Amendments on behalf of the Town.

42 **NOW, THEREFORE,**

44 **SECTION I: BE IT RESOLVED BY THE COUNCIL OF THE TOWN OF RIVERDALE**
45 **PARK** that it hereby ratifies, confirms and validates the Amendments and the execution of the


46 Amendments on behalf of the Town to the fullest extent as if the Council had adopted each of the
