13 **A RESOLUTION concerning**

15 **MADISON HILL PERMIT PARKING AREA**

16
17 **FOR** the purpose of repealing Resolution 2012-R-01 that established the Madison Hill Permit
18 Parking Area; establishing a new Permit Parking Area in Madison Hill; limiting the number of
19 permanent resident parking permits that may be issued for each residence in such Permit Parking
20 Area; and matters generally related thereto.

21
22 **WHEREAS**, under Section 64-13(a) of the Code of the Town of Riverdale Park, the Town
23 Council, by resolution, may designate sections of the Town to be permit parking areas; and

24
25 **WHEREAS**, under Section 64-13(b) of the Code of the Town of Riverdale Park, as amended by
26 Ordinance 2012-OR-02, the Town Council, by resolution, may limit the number of permanent
27 resident parking permits issued for each residence in a permit parking area; and

29 **WHEREAS**, the Town Council determined that a resident Permit Parking Area should be
30 established in the subdivision of Madison Hill, and adopted Resolution 2012-R-01 for that
31 purpose; and

33 **WHEREAS**, after further consultation with residents in Madison Hill, the Town Council has
34 determined that that it is necessary to modify the resident Permit Parking Area that it established
35 in Madison Hill.

37 **NOW, THEREFORE,**

39 **SECTION I: BE IT RESOLVED BY THE COUNCIL OF THE TOWN OF RIVERDALE**
40 **PARK** that the Town Council hereby repeals Resolution 2012-R-01.

42 **SECTION II. BE IT FURTHER RESOLVED THAT** the Town Council hereby creates
43 Madison Hill Permit Parking Area. The Madison Hill Permit Parking Area consists of Signet
44 Lane, Supra Place and Silk Tree Drive.


46 **SECTION III. BE IT FURTHER RESOLVED THAT** not more than two resident permanent
47 parking permits shall be issued for each dwelling unit in the Madison Hill Permit Parking Area.

49 **SECTION IV. BE IT FURTHER RESOLVED THAT** this Resolution shall take effect
50 immediately upon its adoption, or upon the effective date of
51 Ordinance 2012-OR-02, whichever occurs later.
