Town Administrator Sara Imhulse reported:

- The Town received a reduction of \$53,000 in IWIF rates for next year. Ms. Imhulse explained why the IWIF rates are lower for the Town next year.
- The Town was awarded a Community Park and Playground Grant for \$195,000 for the Riverdale Road Park. Public meetings will be held in the future.
- The Town's Bond Bill for the Youth and Community Wing Project (\$250,000) was approved by the General Assembly. The total amount of funding from the State of Maryland is \$816,000.
- State Comptroller Peter Franchot met with 4th Grade classes at Riverdale Elementary School on April 24.
- The next MUTC meeting will be May 8 at 7:30 p.m.
- A Purple Line Open House will be held on May 9 from 5:00 p.m. to 8:00 p.m. at Riverdale Elementary School.
- The TDDP Listening Session will be May 9 from 7 p.m. to 9 p.m. at College Park City Hall.
- The Town Center Open House will be held on June 6 from 3:00 p.m. to 5:00 p.m.

Police and Code Report

Police Chief David Morris reported:

- Recently attended an Active Shooter Conference hosted by Howard County with Captain Timmons.
- In the process of establishing a Chief/Citizen Advisory Council.
- Will be reinstituting the Public Safety Community Walks as the weather gets warmer
