The applicant reported that the rear fence was built because of safety concerns. The applicant also stated that the front yard fence was 4 feet tall and the side and back fence was 6 feet tall. CM Henry stated that he was concerned about the height of the side fence as it extends from the rear building line to the front of the house.

CM Thompson made a motion to adopt Ordinance 2015-OR-02 regarding the FY 16 Budget as introduced. The motion was seconded by CM Lingua. Vote: 5-0 (favorable)

CM Thompson motion to substitute the previously introduced ordinance with the version as presented on June 1, 2015. The motion was seconded by CM Lingua. Vote: 5-0 (favorable)

4. Motion to adopt Mayor's nominations for committee assignments and Council vice-chairman

Mayor Archer nominated CM Thompson as Council Vice-Chair. CM Henry made a motion to adopt Mayor Archer's nomination for Council Vice-Chair. The motion was seconded by CM Lingua Vote: 5-0 (favorable)
